## ANKENY GOLF & COUNTRY CLUB MEMBERSHIP APPLICATION

*Pursuant to the By-Laws the repurchase price of certificate of membership are as follows:*

1. If resignation or expulsion is effective prior to the first anniversary of the membership, the repurchase price of the certificate is zero.
2. If resignation or expulsion is effective on or after the first anniversary of the membership, but prior to the second anniversary, the repurchase price of the certificate is one-half of the membership fee paid by the member for the purchase of the certificate.
3. If resignation or expulsion is effective on or after the second anniversary of the membership, the repurchase price of the certificate is the total membership fee paid by the member for the purchase price of the certificate.
4. For purpose of determining the repurchase price of the certificate of membership, the term "anniversary of membership" as used herein above shall mean each annual date, which coincides with the date appearing on the certificate of membership.
